The ground level and upstairs both show to be approx. 3,750 sq. ft. The Figley-Salz offices have 4 individual offices and 2 bathrooms, 2 separate general office and lobby areas, as well as storage rooms.

Access is from 10th St. and from the north side of the building. The 924 Main location on the south side has a lobby and 2 offices and a conference room and bathroom. Central H/A units heat and cool both addresses. The building received a duralast roof in 2012. The upstairs has entrances from Main St. and 10th St. In years past, this area was home to law offices, land men, and apartments. 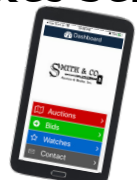
